With the exception of some existing disaster recovery (DR) features, think's technical platform is entirely contained within the Amazon Web Services (AWS) environment, in order to increase efficiency and reduce operational cost.

As think's business evolved with new opportunities, the think management and board of directors defined a requirement for an out-of-cloud copy of data to enable disaster recovery and data accessibility whilst maintaining (on-shore) Australian privacy commitments to their clients. think engaged cloud services firm RedBear IT to develop a solution for immediate and future data availability, and DR capabilities.

Enhancing AWS.

A layered solution was developed using AWS capabilities such as snapshots and an AWS Multi-Availability Zone implementation for immediate data availability. The Enterprise Storage-as-a-Service (STaaS) provider Zadara was chosen from a variety of available traditional and cloud ecosystems solutions to provide an out-of-cloud copy of think's most critical data.

Zadara's cloud-based solution, the Virtual Private Storage Array (VPSA) for block-based storage, was implemented to give think the ability to rapidly access a copy of their data for the purpose of disaster recovery to an alternative cloud or to on-premises temporary hardware, if required.
